In addition to an enrollment form and proof of vaccinations, we will need to do a temperament test before your dog's first stay with us. This is to ensure, for the safety of other client's dogs as well as your own, that we do not have any aggressive dogs in daycare.

## **BARK PARK DOG DAYCARE GENERAL INFORMATION AND POLICIES**

The purpose of Bark Park's daycare center is to provide a safe, fun, and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules and regulations:

**AGE:** All dogs must be at least 16 weeks of age or older.

**SEX:** All dogs 7 months or older must be spayed or neutered.

**SHOTS:** All dogs must have up-to-date vaccinations. Owners must submit written proof of Rabies and DHLPP vaccines within the past 12 months and Bordetella vaccine within the past 6 months (or, if given by injection, within 12 months).

**HEALTH:** All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition in the last ten (10) days. Upon admission, all dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last ten (10) days will require veterinarian certification of health to be admitted or readmitted.

**BEHAVIOR:** All dogs must be non-aggressive and not food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dog(s). Please remember: Your pet will be spending time with other pets and the safety and health of all animals is our main concern.

**APPLICATION:** All dogs must have a complete, up-to-date and approved application on file.

**DAYCARE FEES:** Daycare fees are based on a park pass plan. A pass is valid for 6 months from date of purchase. Additional dogs from the same household are \$10 per day, per dog.

1-day pass:	\$ 20.00	
5-day pass:	\$ 85.00	(\$17.00 per day)
10-day pass:	\$150.00	(\$15.00 per day)
20-day pass:	\$275.00	(\$13.75 per day)
Add'l dogs:	\$10 per day	per additional dog

**BOARDING FEES:** Overnight boarding is \$10 per night for the first dog, and \$5 per night for additional dogs from the same household. Boarding dogs are in daycare during the day, and these rates are charged in addition to the daycare fee.

**HOURS OF OPERATION:** Monday through Friday -- 7:00 a.m. to 6:00 p.m.; Saturday -- 8 a.m. to 5:00 p.m.; Sunday -- 5 p.m. to 6 p.m. (dropoff/pickup only). If a dog is not picked up from daycare by closing time, he/she will be boarded in our facility overnight, and the owner will be charged for boarding.

**RESERVATIONS:** We request that you make reservations in advance if at all possible. However, walk-ins will be accepted on a first-come, first-served basis for dogs who are enrolled in daycare.

### **DOG DAYCARE AGREEMENT**

As Owner of the above-named dog, I represent, warrant, and agree as follows:

1. I understand that, in accepting my dog for services at its facility, Bark Park, LLC, has relied upon my representations contained in my Enrollment Application, including my representations that my dog is in good health and has neither injured nor shown aggressive or threatening behavior to any person or dog.
2. I understand and agree that Bark Park, LLC, its owners and members, employees, volunteers, and insurers will not be liable, financially or otherwise, for injuries to my dog, myself, or any property of mine while my dog is participating in services provided by Bark Park, LLC. I hereby release Bark Park, LLC, of any liability of any kind arising from my dog's participation in any and all services provided by Bark Park, LLC.
3. I further understand and agree that Bark Park, LLC, has complete and sole discretion as to whether to address problems that my dog may exhibit and, if treated or addressed by Bark Park, LLC, any problems with my dog -- behavioral, medical, or otherwise -- will be treated as deemed best by the staff of Bark Park, LLC, in its sole discretion. I hereby appoint Bark Park, LLC, as my agent to incur veterinary bills on my behalf should it, in its sole discretion, elect to do so. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog regardless of how the problems or conditions arise.
4. I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risks. I desire a socialized environment for my dog while at or in the care of Bark Park, LLC. I understand that, while the socialization and play are monitored by the staff of Bark Park, LLC, it is possible that, during the course of play, my dog may receive injuries from other dogs or from the Bark Park, LLC, facilities, and I accept those risks.
5. I understand that, by allowing my dog to participate in services offered by Bark Park, LLC, I agree to allow Bark Park, LLC, to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.

6. I further understand that I am solely responsible, financially and otherwise, for any harm or damage to Bark Park, LLC, third persons, or property caused by my dog while my dog is at or in the care of Bark Park, LLC.
7. If my dog is not picked up on time (i.e. by a date specified in a separate agreement or at the time specified by Bark Park, LLC, whichever is sooner), I hereby authorize Bark Park, LLC, to take whatever action is deemed necessary, if any, at the complete and sole discretion of Bark Park, LLC, for the continuing care of my dog. I will pay Bark Park, LLC, the cost of any such continuing care upon demand by Bark Park, LLC. I understand that, if I do not pick up my animal when agreed, Bark Park, LLC, may, at its complete and sole discretion, proceed according to the guidelines provided by Louisiana Revised Statute 3:2452-2454.
8. I agree to pay Bark Park, LLC, any and all expenses incurred by it, including its attorney's fees if (i) I breach this agreement, (ii) I make a misrepresentation to Bark Park, LLC, or (iii) Bark Park, LLC, is forced to engage an attorney to enforce or defend this agreement or to take steps under La. R.S. 3:2452-2454 with regard to my failure to pick up my dog.
9. I agree to indemnify and hold harmless Bark Park, LLC, as well as its members, managers, employees, agents, and insurers, from and against any claims involving or in any way resulting from the actions or inactions of my dog, all to the fullest extent allowed by law, even if Bark Park, LLC, or its members, managers, employees, agents, and insurers are partly responsible for the resulting injuries and/or damages.
10. I agree to pay all fees and expenses demanded by Bark Park, LLC, when demanded. In the event I fail to pay Bark Park, LLC, all amounts owed when due, I agree to also pay interest on the amount owed at the rate of 18% per annum until paid.
